Subsequent to Technical Validation Session in the matter, and submission of executive summary of PPA and modified PPA by MSEDCL, the Commission has admitted the Petition for further hearing, and has directed MSEDCL to invite comments/suggestions from the public on the above Petition through this Notice.

It should also mentioned if the sender wants to be heard in person, in which case opportunity would be given by the Commission at the Public Hearing to be held at **Mahila Vikas Mandal Sabhagraha, Queen's Barrack No. 1, General Jagannathrao Bhosale Marg, Near Y.B.Chavan Auditorium, Mumbai - 400 021, on Tuesday, March 11, 2008 at 15:00 hours**, for which no separate notice will be given.

5. MSEDCL shall reply to each of the objections/suggestions/comments received within 3 (three) days of the receipt of the same but not later than **March 10, 2008** for all the objections and comments/suggestions received till **March 6, 2008**.
