## **NOTICE INVITING TENDER**

**EMPANELMENT OF VENDORS FOR “DESIGN, SUPPLY, ERECTION, TESTING AND COMMISSIONING INCLUDING WARRANTY, COMPREHENSIVE OPERATION & MAINTENANCE OF GRID-CONNECTED ROOFTOP SOLAR PLANT OF VARIOUS CAPACITIES AGGREGATING TO 50MWp UNDER PHASE-II OF GCRTS SCHEME OF MNRE BEING IMPLEMENTED BY MSEDCL IN THE STATE OF MAHARASHTRA (TWO PART BIDDING e-TENDER) Under E-tender web Portal of State e-procurement Portal (<https://etender.mahadiscom.in/eatApp/>)**

The Ministry of New and Renewable Energy, Government of India (MNRE) is implementing Phase-II of Grid Connected Rooftop Solar (GCRTS) Programme wherein central financial assistance (CFA) is being provided for installation of rooftop solar (RTS) projects in residential buildings. To implement the RTS activities in respect of the aforesaid programme, respective Power Distribution companies (DISCOMs) have been designated as the implementing agency. Accordingly, MSEDCL shall be the tendering agency and will identify L-1 rates and empanel vendors for implementation of the programme.

MSEDCL invites e-bids from eligible bidders to participate in Request for Proposal (RFP) for empanelment of vendors for Site Survey, Design, Installation, Supply, Erection, Testing and Commissioning including Warranty and 5 years of Comprehensive Operation and Maintenance of Roof Top Solar PV Power System for Residential Consumers in MSEDCL jurisdiction of the state of Maharashtra. This RFP shall be governed by terms of sanction received from MNRE

For the implementation of above-mentioned work, Bidders should submit their bid proposal online, complete in all aspect, on or before Last date of Bid Submission as mentioned on the Bid Information Sheet.

Bidder shall submit bid proposal along with non-refundable tender fee and refundable Bid Bond as per the Bid Information Sheet. Techno-Commercial bids will be opened online as per the Bid Information Sheet in presence of authorized representatives of bidders who wish to be present online. Bid proposals received without the prescribed tender fees and Bid Bond shall automatically be rejected. In the event of any date mentioned in bid information is declared a Holiday, the next working day shall become operative for the respective purpose mentioned herein.

Bid documents which include Eligibility criteria, Technical Specifications, various conditions of contract, formats, etc. can be downloaded from <https://etender.mahadiscom.in/eatApp/>. Only the documents submitted at the time of Bid Submission shall be used in evaluation process. Bidders are advised to ensure that all supporting documents are submitted at the time of Bid Submission as no further clarification/amendments would be entertained in this regard. Bidders are also encouraged to familiarize themselves with the MNRE scheme available at SPIN portal ([solarrooftop.gov.in](http://solarrooftop.gov.in)) for efficient execution.

The bidding process under this Rooftop scheme is for \*50MWp comprising of CAPEX Model.

\*The tender capacity may be increased further with approval from MNRE upon achieving/installing 70% of total capacity of the present 50MW tender.

**Note:** For common facilities in Group Housing Societies/Residential Welfare Associations (GHS/RWA) etc. the allowed RTS capacity shall be limited up to 500 kWp (@ 10 kWp per house), with the upper limit being inclusive of individual rooftop plants already installed by individual residents in that GHS/RWA at the time of installation. Bidders are requested to quote at least Minimum Capacities in each part as per above table.

MSEDCL reserves the right for diversion of capacity from one bidder/ category to another (including transfer of unallocated capacity to OPEN Category) for 100% utilization of capacity sanctioned by MNRE, GoI.

MSEDCL reserves the right to allocate balance (unallocated) tender capacity, if any, to the bidder who has satisfactorily completed installation & commissioning of its entire allocated capacity.

Further, changes/modifications if any in the Standard Bidding Document/Guidelines notified by MNRE under Phase-II RTS Programme shall be treated as a part of this RFP.
