Hon'ble MERC has issued the MYT tariff order of MSEDCL on 30-03-2020. Accordingly the prior approval of Hon'ble MERC for charging of FAC to consumers is mandatory from the month April-20 as per tariff order dated 30-03-2020.

Prior approval for FAC of Oct-24 is received vide Ref. No. 2. As per Hon'ble MERC prior approval vide Ref. No. 2 FAC will be billed to consumers for billing month Dec-24.
