For MSEDCL, target is of 20 lakhs households rooftop installation under PM Surya Ghar: Muft Bijli Yojana. In order to achieve this ambitious goal and to accelerate process flow, following various process auto created in new connection system.

- 1. In cases, where RTS application received without selection of empanelled agency by applicant will be process further in New Connection System.
- 2. In cases, where RTS applications received without payment of registration fees will be process further in New Connection System.
- 3. In cases, where RTS application received with pending arrears, will be auto approved and processed further in New Connection System.
- 4. In cases where applied PV capacity is higher than Sanction load or Contract Demand, auto creation of additional load application alongwith RTS application implemented in New Connection System. The technical feasibility in all cases i.e. additional load and RTS applications where applied PV capacity is upto 10 KW, will be auto approved alongwith system generated estimate and application will be automatically processed upto meter installation stage in New Connection System.
- 5. The technical feasibility of RTS PV capacity above 10 KW will be approved in auto mode if no action taken within 15 days.

The guidelines in this regard already issued by this office vide letter as under reference 3,4 & 5.

Further it is instructed to convey all concern field officers to comply following before issuing Solar Net Meter or installation of meter in line with points 1, 2, 3, 4 as above.

- > Empanelled vendor selection done by Consumer/Applicant.
- > Registration fees to be paid by Consumer/Applicant.
- > Pending arrears if any should be recovered from Consumer/Applicant.
- Estimate charges for Additional load if generated by system should be recovered from Consumer/Applicant

If above checks are not complied before installation of solar net meter, concerned employees will be held responsible for further consequences.

Above instructions to be followed scrupulously.
