Sub: Testing of Rooftop solar Net Meters and Generation Whole Current Meter and installation up to 20 KW at Subdivision/Division Offices

Ref: 1) CE/Sp. Proj./MNRE-Phase-11 RTS/No. 21653 dtd. 18.08.2022

Government of India has launched **Pradhanmantri Suryodaya Yojana** with the target of installing rooftop solar on 1 crore residential houses for making India self-reliant in the energy sector. Maharashtra has been given the target of installation of 20 lakhs RTS on residential houses.


Instructions were already given vide letter under ref.(1) authorizing AE QC of subdivision/ division to test Whole Current Meter under Roof Top Scheme (RTS) & to visit site for checking the installation and release connections up to 20KW in consultation with SDO.

It is observed that some subdivisions are not testing solar Net meter, Generation meter and diverting it to Testing division under Circle offices. Also testing benches at some subdivision offices are faulty and some are not having ERSS meter. This is hampering progress of PM Suryaghar MBY scheme.

In view of above following instructions are issued.

- 1) The faulty meter testing bench should be got repaired and ERSS meter to be made available by procurement as per provisions of GO-II on top priority.
- 2) Rooftop solar Net Meters and Generation Whole Current Meter up to 20 KW should be tested at subdivision/division office and should not be referred to circle testing division unless having specific issue of meter testing results .
- 3) In case of a defective meter /meter stuck, burnt, lost or has stopped recording same can be referred to testing division of circle office for testing for billing complaint issues.
- 4) Meter testing should be done immediately without waiting for SOP period completion.

It is directed to follow instructions scrupulously.
