Qualifying Requirements:

1. Bidder should be a single company/firm. No joint venture or consortium is allowed. The bidder must be able to meet the full requirement of Request for Proposal (RFP). The bidder cannot form a consortium or subcontract the execution of the order to other parties.
2. The Bidder should be in existence for the last 5 years in the areas of Website development / Payment Gateway management / API management and software development, server

security and managed services. Suitable documentary evidences must be submitted.

3. The bidder should have Average Annual Turnover of Rs. 24.00 lakhs during the last 3 years (FY 2014-15, 2015-16, 2016-17).
4. The Bidder should have a positive net worth and should be in profit from IT business in each of the last three audited financial years
5. The Bidder should have successfully implemented / implementing Website Services / API management & multiple Payment Gateways and software development in at least one Utility / Nationalized or Scheduled Bank in India. The bidder should have maintained at least 3 websites including at least one Government / Government Undertaking Website in last 3 years.
6. The bidder should currently maintain multiple payment gateway providers and aggregators having greater than 75000 online transactions on daily basis with regular reconciliation process. It should be demonstrated on demand.
7. The bidder should have experienced qualified team in the areas of HP-UX, Linux, Oracle, MySQL and PHP on its payroll for at least 3 years.
