Instructions to Bidders - Point No.- 2(2.3 to 2.6)(Qualification of Bidders) (Section-I (ITB) of Tender Documents)-

2.3 The bidder should have experience of similar nature (i.e. in the field of taking Meter Reading through CMRI of HT or CT operated Energy Meters in MSEDCL/any power utility) for during last 2 years for at least order value of Rs. 5.00 Lac per year (Information provided by the contractor with regards to the qualifying requirements stated in clause No. 2.2 above needs to be supported by satisfactory work completion certificate issued by the office not below rank of Executive Engineer.).

2.4 Valid Electrical contractor's license issued under the act from Maharashtra State.

2.5 The bidder will have to submit solvency certificate from Nationalized/Scheduled Bank to the extent of 25% of the Tender amount before 6 months period.

2.6 Registration for GST & Bombay Shop Establishment Act Registration

This may be read as-

"2.3 The bidder should have experience of similar nature (i.e. in the field of taking Meter Reading through CMRI of of IP Meters consumers in MSEDCL/any power utility) for during last 2 years for at least order value of Rs. 6.00 Lac per year (Information provided by the contractor with regards to the qualifying requirements stated in clause No. 2.2 above needs to be supported by satisfactory work completion certificate issued by the office not below rank of Executive Engineer.).

2.4 General Experience: The Bidder should have executed either (i) a single order equivalent to at least 20% of the Estimated Cost of the Works , or (ii) two orders equivalent to at least 25% of the Estimated Cost of the Works, or (iii) three orders equivalent to at least 30% of the Estimated Cost of the Works in any sector during the last five financial years; (2013-14,14-15,15-16,16-17,17-18) and

2.5 Specific Experience: The Bidder should have prior experience in executing a single order of similar nature of work in transmission and distribution sectors/ systems of a minimum value of 15% of the Estimated Cost of the Works, during the last five financial years; (2013-14,14-15,15-16,16-17,17-18) and

2.6 The bidder should have minimum 2 years experience in meter reading through CMRI in MSEDCL for having minimum 80% consumers which are required to be billed in that subdivision, total numbers of consumers having load more than 20HP per month such experience should have been with in preceding 5 years (2013-14,14-15,15-16,16-17,17-18)."


