The Chief General Manager (IT), on behalf of Maharashtra State Electricity Distribution Company Limited (the Employer), hereby invites sealed bids from eligible bidders for **Appointment of Network Bandwidth Service Provider for provisioning of 50 Mbps MPLS (1:1) Leased Lines at MSEDCL Software Cell Locations for period of 3 years.**

**Tender Fee: Rs. 2500/- Plus GST tax at the rate of 18%.**

The bidder should submit non-refundable Bid Fee of **₹2500/- Plus GST** in the form of online payment on e-Tendering Website.

**Bid Security / EMD :** The bid must be accompanied with Bid Security for an amount of **₹41,090/- (Rupees Forty One Thousand & Ninety Only)**. The bid security shall be in the form of Online on MSEDCL e-tender Portal or an Unconditional Bank Guarantee from any Nationalized / Scheduled Bank in favor of the Maharashtra State Electricity Distribution Co. Ltd., payable at Mumbai.

The Bank Guarantee should be submitted to this office on or before submission date and time.

### **Brief Scope:**

Bidder shall supply, install and commission the dedicated 50 Mbps MPLS Leased Lines (1:1) at the Software Cell locations for the contract period of 3 years as per Section X. Annexure-III List of Locations.

### **PRE-QUALIFICATION CRITERIA:**

#### **❖ Pre-Qualification Criteria for Network Bandwidth Service Provider:**

- The bidder should be a single company registered / incorporated in India under companies act 1956 and 2013 or LLP with registered office in India and should have been in operation in India. The Bidder should have been in operation for a period of at least 3 years in Telecom industry.
- Bidder should be a National Long-Distance Service Provider or IP VPN service provider having own MPLS Leased line network under license from Govt. of India. This License should be valid during the contract period.
- Bidder should have valid PAN and GSTIN number.
- Bidder should have average annual financial turnover of at least Rs. 1 Crore for the last three audited financial years.

- Bidder should have **Supplied, Installed, Integrated, Tested and Commissioned wired / wireless MPLS Leased Lines in any sector in India, during preceding seven years (till the date of bid submission)** fulfilling any one of the following criteria:
  - One similar work order/contract (denotes executed only) equivalent to at least Rs. 33 lakhs.
  - Two similar work order/contracts (denotes executed only) costing not less than Rs. 21 lakhs each.
  - Three similar work orders/contracts (denotes executed only) costing not less than Rs. 17 lakhs each.
- The Bidder should have relevant ISO/BSI or TL9000 certification.
- The Bidder must not be under a declaration of ineligibility / banned / blacklisted by any State or Central Government / any other Government institutions in India for any reason as on last date of submission of the Bid or convicted of economic offence in India for any reason as on last date of submission of the Bid. Bidder should comply all conditions mentioned in MSEDCL POLICY & PROCEDURE FOR DEBARRING OF AGENCY (enclosed as Appendix 1).
