The bid security shall be in the form of Online on MSEDCL e-tender Portal or an Unconditional Bank Guarantee from any Nationalized / Scheduled Bank in favor of the Maharashtra State Electricity Distribution Co. Ltd., payable at Mumbai.

Brief Scope:

Cyber Security Audit shall be conducted of MSEDCL Web facing & Business Critical Applications.

Qualification Requirements:

1. The bidder must be Company registered in India under companies Act 1956 or Companies Act 2013, or Firm registered with Registrar of firms and societies in India who fulfils the eligibility criteria. Kindly note that consortium / joint venture / partnership / similar arrangement will be disqualified.
2. The bidder must be an empanelled auditor of CERT-In, having an empanelment certificate.
3. The Bidder shall have a valid PAN and GSTIN Number.

4. Bidder should have average annual financial turnover of at least Rs. 11.3 lakhs for the last three audited financial years.
5. The Bidder should have positive Net worth after tax during each of the last three consecutive financial years (ie. FY19-20 & FY20-21 & FY21-22.).
6. The Bidder should have executed at least 3 orders in last five years of similar nature of jobs, particularly in Cyber Threat & Vulnerability Assessment and/or Site Security Audit Services at any Govt. Department / Quasi Govt. Dept / PSU / Board / Council.
7. The bidder must not be under a declaration of ineligibility / banned / blacklisted by any State or Central Government / any other Government institutions in India for any reason as on last date of submission of the Bid or convicted of economic offence in India for any reason as on last date of submission of the Bid. Bidder should comply all conditions mentioned in MSEDCL POLICY & PROCEDURE FOR DEBARRING OF AGENCY (enclosed as Appendix 1).
8. The firm should have complete understanding of Indian statutory laws, cyber law, IT Act, governance, taxes / duties, Government budget updates, import / export updates & implementation for Clients of similar stature.
9. The Bidder should be certified for ISO 27001:2013 and ISO 9001: 2015.
10. The Bidder must have certified auditor as mandated by CERT-In.
