Bid Security: The bid must be accompanied with Bid Security for an amount equal to **INR 53,47,677/-** (Fifty Three Lakh Forty Seven Thousand Six Hundred Seventy Seven Only) for covering the entire scope of work. Brief Scope of Work for SD-WAN

The brief scope of aforesaid SDWAN implementation tender is as under,

- 1. Supply, Installation, Configuration, Commissioning and management of SD-WAN solution up to Subdivision Offices (4 Regions, 16 Zones, 46 Circles, 147 divisions, 652 subdivisions).
- 2. It is bidders' responsibility to integrate any new or existing FTTH broadband, MPLS, ILL, broadband link (provided by MSEDCL) on supplied Wi-Fi enabled SD-WAN device during the contract period. The SD WAN Device(s) integrated with external Wi-Fi access points, must be configured as per requirement.
- 3. Bidder has to provide the new wall mount rack, cable manager, jack panel with UPS sufficient for supplied devices along with industry standardized earthing for supplied equipment's.
- 4. Bidder is responsible for Supply, Installation, Configuration, Commissioning, and management of cloud instances for entire SD-WAN solution and its integration with existing MSEDCL cloud environment where MSEDCL applications are hosted.

- 5. Bidders' responsibility to provide 1-year on-site OEM comprehensive warranty + 4-year on-site OEM comprehensive AMC for entire SD-WAN solution hardware and software from date of successful commissioning. The 4 Years AMC shall start after completion of 1 year warranty.
- 6. It is bidders' responsibility to provide operational training of SDWAN network and related appliances to concerned MSEDCL staff at locations.
- 7. It is bidders' responsibility to shift the supplied equipment's in case of office shifting.
