The Chief General Manager (IT), on behalf of Maharashtra State Electricity Distribution Company Limited (the Employer), hereby invites online bids from eligible bidders for Request for *Proposal for Selection of System Integrator (ERPSI)* for *"Upgrade of SAP ECC to RISE with SAP S/4 HANA for 5 years, Installation, Commissioning, Implementation of SAP TRM and Cash Management module and 2 years of Application Maintenance Services for all core and custom modules at MSEDCL"*. The entire bidding document is available on MSEDCL's Website as per the date indicated below. Any changes in the Bid Schedule, corrigendum etc. shall also be notified via MSEDCL's website. Prospective bidders are therefore requested to regularly check the website for any updates.

Bid Security (EMD): The bid must be accompanied by Bid Security for an amount equal to Indian INR **1.17 Cr** for covering the entire scope of work. The bid security shall be denominated in Indian Rupees only. The bid security can be paid online or in the form of an Unconditional Bank Guarantee from any Nationalized / Scheduled Bank in favour of the Maharashtra State Electricity Distribution Co. Ltd., payable at Mumbai as mentioned in details in the Tender Document (RFP). The BG EMD (original copy) should be submitted to this office on or before the Bid end date.

Brief scope of work

The ERPSI shall be required to carry out the scope of work which shall include but not be limited to the following:

- 1) System to be migrated from SAP ECC to S4 HANA on Rise Platform. Compatible infrastructure serving appropriate system tier for specified usage tier should be provided by bidder for development, production, and testing environment as recommended by SAP
- 2) Some of the MSEDCL applications are on non-Rise Platform are also to be managed (including updates) by ERPSI. Such as HANA in-Memory database, BOBJ, BW for HANA, PO/PI, SYBASE ASE Database for billing system

- 3) Upgradation of SAP ERP ECC6 EHP 5.0 platform to RISE with SAP S/4 HANA (latest version) for Core Modules (FICO, PM, PS, MM,HCM) and implemented custom developed modules in MSEDCL including data migration.
- 4) Implementation of Treasury and Risk Module (TRM) on RISE with S4 HANA.
- 5) Implementation of Cash Management Module on RISE with S4 HANA.
- 6) Upgradation of Solution Manager from 7.1 to 7.2 (or latest version) on HANA.
- 7) Upgradation of PI to PO on HANA
- 8) Upgradation of existing 1 TB HANA appliance (Base edition) to 2 TB HANA appliance.
- 9) Application Maintenance Services (AMS) towards Support, Maintenance & Enhancement of all existing SAP systems (Core & Custom modules) at MSEDCL till declaration of go-live of SAP S/4 HANA.
- 10) Application Maintenance Services (AMS) for 1 year after go-live declaration of RISE with S/4 HANA, towards Support, Maintenance & Enhancement of all upgraded SAP-ERP modules on S/4 HANA (FICO, PM, PS, MM, HCM, TRM & Cash Management) & implemented custom developed modules.
