

Instructions to be followed before publishing the Notice:

1. The M.S.E.D.C.L. emblem should invariably be published at the left hand corner at the top and it should be of the same size supply by publicity section.
2. The vacant space on the right side at the top should be utilized to display headings in this case 'Tender Notice'.
3. Space for advertisement should not occupy more than one column space.
4. Spacing/leading while printing the text matter of the advertisement should be kept minimum.
5. The office address of the undersigned should only be given at the top.
6. The name of the Company "Maharashtra State Electricity Distribution Company Ltd" should not be repeated at the top as the same are already incorporated in the emblem. Similarly, telegraphic address, telephones, date on which advertisements are issued etc. should not be given in the advertisement.
7. At the end of Advertisement only the designation of the office is to be printed and it should be in 8points (bold type) for English Papers and 12 points (Bolt Type) for regional newspapers.
8. The text matter of the advertisement preferably should be in 6 points and in no case should exceed 8 points as far as English News Papers are concerned and in any case should not exceed 10-12 points as far as the regional language newspapers are concerned.


