

## ADDENDUM No. 12

**Subject: Addendum No. 12 to the RFS.**

In respect of the Request for Selection numbered CE/PP/ Thermal+Solar/02 issued on March 13, 2024 (“RfS”) for procurement of power on long term basis through competitive bidding process from a 1,600 MW thermal power project and a 5,000 MW grid connected solar photovoltaic power project, the Bidders to note that:

1. The definition of “Contracted Capacity” in the RfS shall stand revised as under:

*“Contracted Capacity” means the AC capacity of the project contracted with MSEDCL for supply of power from the Solar Power Project by the power producer at the Delivery Point which shall be equal to 5000/2500 MW.*

2. The definition of “Scheduled COD” in the RfS shall stand revised as under:

*“Scheduled COD” or “Scheduled Commercial Operation Date” or “Scheduled Commencement of Supply Date” or “SCSD” for each Phase shall mean the date occurring as per period as mentioned in the table below, from the date of execution of the PPA.*

3. Paragraph 3.14.1 of the RfS shall stand revised as under:

*“3.14.1 The Projects shall be commissioned in four (4) phases for full capacity (5000 MW)/ three (3) phases for 50% capacity (2500 MW) as set out below:*

Capitalized terms used but not defined herein shall have the meaning as ascribed to them in the RfS.

Other than to the extent expressly modified as above, all other terms and conditions of the RfS remain the same and this corrigendum will remain an integral part of the RfS.
