7	MSME Certificate (ITB 10.2.8)	MSME status of Contractors for each further financial year shall be submitted at earliest after end of current financial year. In case of JV Partner, Lead Partner shall submit MSME Certficate.
8	Submission of Power of Attorney (Form 4)	Bidders should submit the POA as per SBD only. If bidder has submitted General POA, we may ask to submit POA as per Form 4 only.
