

## **MSEDCL ADVT. NO. 04/2023**

## SELECT LIST FOR THE POSTS OF SUPERINTENDING ENGINEER (DIST.)

----

- 1. An Advt. No. 04/2023 was published for filling in various posts. The last date of submission of application was 27/07/2023.
- 2. Based on the scrutiny of the application and documents submitted by the candidates, who have applied for the post of Superintending Engineer (Dist.), the list of Eligible, Provisionally Eligible & Ineligible candidates was published on the website of the Company on 05/01/2024. The Provisionally Eligible & Ineligible candidates were given an opportunity to submit their representations, if any.
- 3. Based on the scrutiny of the representations submitted by the candidates, the Final List of Eligible candidates along with instructions/guidelines were published on website of the Company on 23/02/2024.
- 4. The assessment process was held on 02-03 March 2024 at Mumbai. Taking into consideration the performance of candidates in In-basket exercise, other tests and interview, the Select List for the post of Superintending Engineer (Dist.) is prepared.
- 5. As per the guidelines received from GoM, the EWS posts are merged with OPEN category for the posts of Superintending Engineer (Dist.).
- **6.** The Select List will not confer any right on the candidate for appointment. The selection of the candidates is purely on provisional basis subject to confirmation of the pre-requisites and other conditions as notified in the advertisement.
- 7. The candidate should ensure that he / she fulfills the eligibility criteria regarding educational qualification, experience, age, caste etc., and particulars furnished in the application form are correct in all respect. If any false /incorrect information furnished by the candidate is detected at any stage of recruitment process, then his/her candidature will not be considered.
- 8. Please note that it shall be sole responsibility of the candidate to prove his eligibility with respect to the experience in the relative responsible post/position. In case the applicant fails to do so, then his / her candidature will be liable to be cancelled at any stage of recruitment / appointment process.
- 9. The Company will take up verification of eligibility of the candidates with reference to original documents prior to issuance of the appointment letter. The decision of the Company in all matters of recruitment / interpretation shall be final and no individual correspondence will be entertained.
- 10. The candidates who are already employees of the Company, their selection is provisional subject to verification of educational qualification, experience, disciplinary action and F.I.R. etc., if any and other service record.
- 11. While every care has been taken in preparing the results, MSEDCL reserves the right to rectify any inadvertent or typographical error.

- 12. MSEDCL will not entertain any correspondence from unsuccessful candidates.
- 13. Please note that, after verification of certificates/credentials at the time of joining and thereafter if it is found that the candidate do not fulfill the prescribed qualifications for this post as given in the advertisement or any claim/ certificate/document is found to be forged/ Invalid/fraudulent, appointment is liable to be cancelled.
- 14. This selection process/ appointment of candidates will be subject to final outcome of the writ petition No. 4883 of 2024 before the Hon'ble High Court, Bombay, Judicature Aurangabad.
