Corrigendum to Commercial Circular No 320: 345

Subject: Power supply to individual entrepreneurs coming under one premise for Textile and Non- Textile Consumers. – Corrigendum thereof.

Ref : Commercial Circular No. 320 dated 19/07/2019.

Commercial Circular No. 320 issued for providing Power supply to individual entrepreneurs coming under one premises for Textile and Non- Textile Industries. Corrigendum was issued to Commercial Circular No.320 dated 19.07.2019 by Circular No 328 Dt 30.07.2020 in which this circular was made applicable to all categories HT / LT Consumers under one premise through multipartite agreement

In view of certain issues regarding giving power supply at Retail Gas Filling Stations, Petrol Pumps & Service Stations with LT connection as Secondary Connection with EV tariff and by keeping HT connection as Primary Connection with multiparty agreement, following corrigendum to be taken into consideration.

Consumer may opt connections under multiparty arrangement as follows;

1. Connections under Multiparty arrangement:

- a) Main Consumer: Consumer may opt for Multiparty arrangement, as 'Retail Gas Filling Stations, Petrol Pumps & Service Stations' and Other facilities such as restaurant, rest rooms, convenience stores, etc., shall be charged at tariff applicable to Commercial Category as Main Consumer,
- b) Secondary Consumer: Electric Vehicle Charging Station including battery swapping station for Electric Vehicle connection should be Secondary Connection and Electric Vehicle (EV) Charging Stations tariff category is applicable to this connection.
- 2. In case of standalone EV Charging station it will become as Main Consumer billed under Electric Vehicle (EV) Charging Stations tariff category and other facilities such as restaurant, rest rooms, convenience stores, etc. shall be charged at tariff applicable to Commercial Category as Secondary Consumer.
- **3.** The electrical network arrangement should be segregated properly and its timely verification need to carry out to check usage of connections is being used for purpose it is sanctioned.
- **4.** All terms and conditions specified under Commercial Circular No.320 dated 19.07.2019 to avail connections under multiparty arrangements should follow. As per approval of Competent Authority policy may formulated for giving connection for Electric Vehicle Charging Station at existing Petrol pump or standalone Electric Vehicle Charging Station.

All terms and conditions specified under Commercial Circular No.320 dated 19.07.2019 will remain unchanged. All field officers are directed to take needful actions as per above guidelines issued.
