OFFICE ORDER

As per approval accorded by the Competent Authority viz., Chief General Manager (T&S) Eklahare, the result of 103rd Professional Examination for Engineers which was held on 10-Aug-2024 to 11-Aug-2024 is declared as under. Out of 636 employees 521 have appeared for the examination, 157 employees are declared successful in the examination.

As per the provisions of the Administrative Circular No. 618 dated 17.02.2021 readwith GSO 4 dtd. 14-05-1955 & all the fresh entrants Junior Engineer (O&M / Civil) and Assistant Engineer (O&M / Civil) should pass the examination within 3 years of joining. They will be eligible to appear for the examination after completion of 1 year.

As per Administrative Circular No. 618 dated 17.02.2021

1. Junior Engineer (O&M / Civil) and Assistant Engineer (O&M / Civil) Paper I & Paper II are mandatory, result shown as Pass P-I, P-II / Fail and other papers exempted.
2. For Civil Engineers - Paper I & II are of 50 marks and III & IV are of 100 marks.
3. Deputy Ex. Engineer (O&M / Civil) & Additional Ex. Engineer (O&M / Civil) all papers are compulsory. Result is shown as passed, if they pass in all subjects.
4. Overall passing marks will be 45% in each paper irrespective of attempt.

As per the provisions of the G.S.O. 55 dtd. 13th Feb 1956 readwith C.S.No. 2 dtd. 06-07-1984 the candidates who have secured marks in fraction are rounded to the next number i.e. 27.6 is rounded to 28 etc.
