# **Data Privacy Policy for MSEDCL Website (www.mahadiscom.in)**

### 1. Introduction

Mahavitaran (Maharashtra State Electricity Distribution Company Limited), hereafter referred to as "MSEDCL," is committed to protecting the privacy and security of all personal information collected through its official website, www.mahadiscom.in. This Data Privacy Policy outlines how we collect, use, store, and protect your personal data in compliance with applicable laws, including the Digital Personal Data Protection Act (DPDP Act), 2023 and the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016, where applicable.

By accessing or using the MSEDCL website, you agree to the terms outlined in this policy. If you do not agree with these terms, please refrain from using the website.

# 2. Scope

This policy applies to all personal data collected through the MSEDCL website, including but not limited to:

- Consumer account registrations
- Bill payments and transactions
- Service requests and complaints
- Feedback forms and surveys
- Any other interactions with the website

It does not cover third-party websites or services linked to our website.

# 3. Types of Data Collected

We collect two types of data: Personal Data and Non-Personal Data.

3.1 Personal Data

Personal data refers to any information that can directly or indirectly identify an individual. This may include:

- Name
- Address
- Contact details (phone number, email address)
- Consumer ID/Number
- Payment details (e.g., bank account information, credit/debit card details)
- Aadhaar number (if voluntarily provided for specific purposes under the Aadhaar Act, 2016)
- IP address (if linked to an identifiable individual)
- Any other information voluntarily provided by users

#### 3.2 Non-Personal Data

Non-personal data includes information that cannot be used to identify an individual, such as:

- Browser type and version
- Operating system
- Pages visited on the website
- Time and date of access
- Cookies and similar technologies

### 4. Purpose of Data Collection

We collect and process your personal data only for legitimate purposes, which include:

- Providing electricity billing and payment services
- Processing service requests and resolving complaints
- Improving customer experience and website functionality
- Conducting audits and analysis to enhance operational efficiency
- Complying with legal obligations and regulatory requirements
- Sending notifications about outages, updates, or promotional offers (with consent)

In cases where Aadhaar numbers are collected, they will be used strictly in accordance with the provisions of the Aadhaar Act, 2016, and only for purposes explicitly authorized by law, such as identity verification or authentication.

### 5. Legal Basis for Data Processing

The processing of your personal data is based on one or more of the following legal grounds:

- Consent: You have explicitly provided consent for specific purposes.
- Contractual Necessity: Processing is necessary to fulfill a contract with you.
- Legal Obligation: Processing is required to comply with applicable laws, including the DPDP Act and the Aadhaar Act, 2016.
- Legitimate Interests: Processing is necessary for our legitimate business interests, provided it does not override your rights.

The following Acts/regulations will be followed to ensure that your personal data is processed lawfully, fairly, and transparently.

- (a) the Aadhaar Act, 2016 the regulations made thereunder, and the standards and specifications issued by UIDAI from time to time.
- (b) the Information Technology Act, 2000 ("IT Act"); and
- (c) till the coming into force of the Digital Personal Data Protection Act, 2023 ("DPDP Act"), the Information Technology (Reasonable Security Practices and Procedures and Sensitive Personal Data or Information) Rules, 2011 ("SPDI Rules") and, on and from the date of

coming into force of the DPDP Act, the said Act and the rules made thereunder.

### 6. Data Sharing and Disclosure

We do not sell, trade, or rent your personal data to third parties. However, we may share your data under the following circumstances:

- Service Providers: Third-party vendors who assist us in operating the website, processing payments, or providing services.
- Government Authorities: When required by law or to protect our rights and property.
- Business Transfers: In the event of a merger, acquisition, or sale of assets.
- Consent: With your explicit consent for specific purposes.

All third parties are obligated to maintain confidentiality and adhere to data protection standards. For Aadhaar-related data, sharing is strictly prohibited unless mandated by law under the Aadhaar Act, 2016.

#### 7. Data Retention

Retention periods are determined based on regulatory, operational, and security needs. We retain your personal data only for as long as necessary to fulfill the purposes outlined in this policy, unless a longer retention period is required by law. After the retention period expires, your data will be securely deleted or anonymized. The following retention periods apply:
